**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 4 SEPTEMBER 2017**

At the Annual General Meeting of Wah Ha Realty Company Limited (the “Company”) held on 4 September 2017 (the “AGM”), the Chairman of the AGM demanded a poll for voting on all the proposed resolutions as set out in the notice of the AGM dated 25 July 2017.

As at the date of the AGM, the total number of shares of the Company in issue was 120,960,000 shares (the “Shares”), representing the total number of Shares entitling the shareholders of the Company (the “Shareholders”) to attend and vote for or against all the resolutions proposed at the AGM.
